1. Call to Order

The NORCOM Governing Board was called to order by Jim Torpin, Governing Board Chair, at 9:02 a.m. on October 9, 2015.

2. Roll Call

Chief Torpin requested a roll call of present Governing Board members. A quorum was established.

3. Open Communications from the Public

There were no requests to address the board.

4. Employee Recognition

Director Orr presented Telecommunicator Ashley Grannis with a Director's Coin related to Kirkland Police Department's commendation for her role in a domestic violence incident.

5. Action Items

A. Consent Calendar

Marilynne Beard made a motion to approve the items on the Consent Agenda. Mark Risen seconded the motion. Items included on the Consent Agenda were: Minutes from the September 11, 2015 Governing Board Meeting, Accounts Payable Approval Report for September 1 through 30 2015 (Accts Payable Total: \$930,283.37), and Asset Disposal. The motion was approved.

6. Old Business

A. Fire Projects Update

- i. Fire Mobile-CAD Implementation Project This is not yet closed out. The concern is realted to an MDC losing connection to a GPS port. There has been no reoccurrence since 9/15/15 fix. NORCOM is continuing to monitor this.
- ii. TriTech CAD Major Upgrade Project This upgrade occurred August 17/18 2015.It went well with no Priority 1 or Priority 2 issues.
- iii. eCBD—Initial testing went well and it has been installed for operations testing on 10/8/15. NORCOM expects to implement it soon.

B. Police Projects Update

- i. 10.2 Project Upgrade
 - 10.2 was deployed to production on February 24, 2015. There is 1 remaining Priority 1 issue and 6 Priority 2 issues. Three fixes have been delivered and are in testing. NORCOM is monitoring for a reocurrence.
 - May 12th New World Outage Began at 12:10 on 5/12, service restored at 16:20 on 5/13. The root cause has been identified as a bug in the NWS installer app & port issue with Microsoft. There is not yet a closeout from NWS.
- ii. Kirkland 2-Factor Authentication launched on 10/5 and is going well

- iii. LInX Replacement Interface The existing LInX interface has not worked since 10/2014. The extraction utility is installed and NORCOM is currently configuring and testing.
- iv. Message Switch negotiated 30% reduction in install costs. This is a physical server installation.
- v. Tyler Technologies merged with New World and will be integrating their software to include courts, jails, and prosecutors.

C. E911 Financial Stability Discussion

Council staff facilitated discussion with Seattle Council/PSAP, KCSO, KC Executive's Office, Nine PSAP Coalition, Sound Cities Association. NORCOM received a draft proposed ordinance last night which establishes a framework for a process to develop a King County Regional 911 plan. It establishes 3 groups (15 member leadership group, 6 member project coordination team, and 13 member interim advisory group). Groups are directed to work by consensus. There will be a facilitator for each of these groups (independent and subjective). Marilynne shared information about the facilitator process as well as her support of the membership of the groups. The ordinance may be on the RPD agenda next Wednesday. Director Orr reviewed the purpose and roster of each of the 3 groups.
